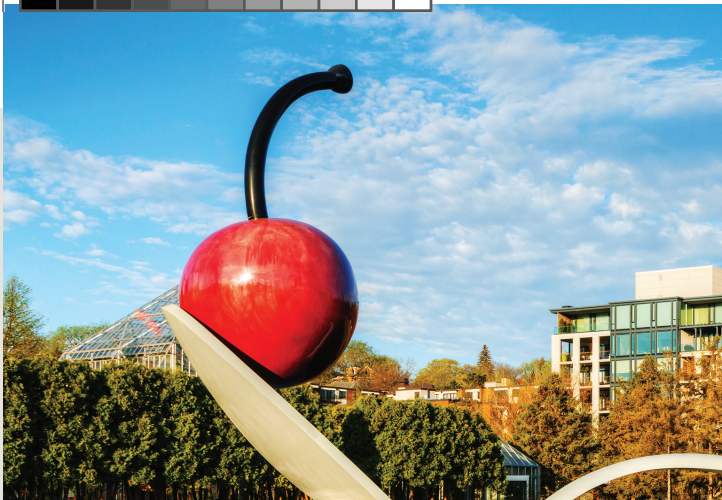

AMERICAN INDIAN EDUCATION

Jesse Kodet is an enrolled citizen of the Lower Sioux Indian Community. Born and raised in Morton, Jesse graduated from Redwood Valley High School in 1997 and completed several years of college at MSU-Mankato and Anoka-Hennepin Tech. He has dedicated his career to working for the community and now serves as the Lower Sioux Education Coordinator, where he is collaborating to expand mentoring toward educational pathways for younger tribal citizens.

He will be speaking on the following topics: ***American Indian Student Definition*** (Minnesota Statutes 2024, section 124D.73, subdivision 5); ***Indigenous Education for All Students*** (Minnesota Statutes 2024, section 120B.021, subdivision 5); ***Tribal Regalia at Graduation Ceremonies*** (Minnesota Statutes 2024, section 124D.792); and ***Standards Development*** (Minnesota Statutes 2024, section 120B.021, subdivision 2(a)).

Jesse recommends reading the following books: Charles Eastman's ***Indian Boyhood***, ***The Soul of the Indian***, and ***From the Deep Woods to Civilization*** for starters.

REAM Educator and John Moriarity Awards

Deadline July 31, 2026

The REAM Educator Award will be presented during the annual conference at the Jackpot **Junction Casino Hotel in Morton, MN on September 28-29, 2026.** The awards are given on Monday, September 28 at 5:15 p.m. This award is given to a noteworthy REAM member who has contributed to the growth of REAM or a local REAM unit. To nominate an individual or individuals, please use the following criteria:

1. Personal endeavors as a school educator
2. Promotion of the causes of education within the community
3. Service to schools and community as a volunteer
4. Service to retired educator groups at the local, division, and/or state level.

Letters of nomination should be brief and concise, but include the following items in the individual's resume:

1. Name, address, education (place, dates, degrees, etc.)
2. Teaching (or school related) places, level or work, years in service
3. Date retired
4. Experience, other than school-related
5. Honors received, organizations, offices held, etc.
6. Volunteer activities, church, community, etc.
7. Service to retired educator groups at local, division, and/or REAM level.

The John Moriarity Government Involvement Award is given to a retired educator and member of REAM who is/was involved in local, county, state, and/or national government activities and political activities such as REAM/AARP legislative activity, political party involvement and/or campaign work.

Possibilities to consider for this award are those who are/were:

- Elected or appointed to community government positions such as city councils, city commissions and board, or school boards
- Elected or appointed to county government positions such as county commissions and boards, or study or research groups
- Elected or appointed to state government positions such as state officers and commissioners, legislature, interns or advisors, or pension positions
- Elected or appointed to national offices such as cabinet members, Congress, staff assistants or interns, or those serving on boards or commissions involved in political activity such as REAM or AARP legislative activity, political party activity, or campaign workers.
